In compliance to the letter dated 09.09.2024 of Medical Assessment and Rating Board (MARBH) referred above, an affidavit has been received from the Principal/Authority of Late Mrs. Housabai Homoeopathic Medical College and Hospital, Maharashtra

The college has applied for permission for conducting the undergraduate (BHMS) with intake capacity of 100 seats for the Academic year 2024-2025 through online portal. MARBH examined the profile of the college to assess the compliance to minimum essential standards to be fulfilled as per the regulations enforce at the time of calling applications and other provisions of NCH Act 2020. On careful examination of the report and inspection conducted on 12/07/2024 and 13/07/24 dates following shortfalls have been observed:

Hospital facilities

- It is observed that the hospital functions along with allopathic medical management and there is no proper policy as to when and where the allopathic medicines will be used in homoeopathic hospital, college shall establish an exclusive Homocopathic Hospital as per prevailing regulations of its own in a separate building.
- The hospital pharmacy needs improvement. Indenting process and labeling of medicines specially with LASA medicines should be done properly

The pharmacist experience certificate was not available on the day of visit.

PD observed no infection control practice or BMW management.

Therefore, considering the above observations and facilities available, Medical Assessment and Rating Board has decided to issue **Conditional Permission to Late Mrs Housabai Homoeopathic Medical College and Hospital, Sangli-Kolhapur Highway, Ichalakaranji Phata Near Dharmanagar, Nimshirgaon, Tal-Shirol, Dist-Kolhapur,**

**Maharashtra for conducting UG (BHMS) course with 100 seats for the academic year 2024-2025.**

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

It is further to mention that all admissions shall be made for NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by respective counselling authority of State/UT Govt. as designated by Central Government/NCH for A.Y 2024-25 and counselling for the remaining 85% seats or as the case may be, conducted by the concerned Counselling Authority of the State/UT.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

**Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.**
